Susan Goodin, Pharm.D, received her Doctor of Pharmacy degree with high distinction from the University of Kentucky College of Pharmacy, completed an ASHP-accredited Pharmacy Practice Residency at the University of Kentucky Medical Center, and an Oncology Pharmacy Residency at the Lucille P. Markey Cancer Center in conjunction with the University of Kentucky Medical Center. She is the Associate Director of Clinical Trials and Therapeutics at the Cancer Institute of New Jersey (CINJ), an NCI-Designated Comprehensive Cancer Center. She has expertise in the development and conduct of cancer clinical trials and directs the implementation of translational trials while providing leadership to pharmacy and nursing. She has practiced at CINJ for 18 years where she has been Director since inception and she established the Clinical Research Office and the pharmacy. She holds an Adjunct Professor appointment at the Ernest Mario School of Pharmacy, is a Board Certified Oncology Pharmacist, and was elected a Fellow of the American College of Clinical Pharmacy in October 2006.

An active clinician and researcher, Dr. Goodin has given many presentations throughout the United States, Canada, and Europe, and has published extensively in journals such as the *American Journal of Health-System Pharmacy*, *Cancer*, *Clinical Cancer Research*, and the *Journal of Clinical Oncology*, to name a few. Her research focus is on the development of novel agents and combinations for the treatment of prostate cancer and natural products for the prevention of cancer. She served on the Editorial Board of the *American Journal of Health-System Pharmacy*, was the founding editor-in chief of *The Oncology Pharmacist* and is currently on the Editorial Board of *Clinical Therapeutics*. She also serves as a reviewer for a number of pharmacy and cancer journals, and an abstract reviewer for a number of meetings including the ASHP Midyear Clinical and Summer Meetings.

Dr. Goodin is an active clinician within the Section of Clinical Specialists and Scientists (SCSS) of ASHP previously serving as Executive Committee Chair and Director-At-Large, Chair of the Section Advisory Group on Gene Therapy, and as the Network Facilitator for Hematology/Oncology. Additionally, she was the co-coordinator and content matter expert for the inaugural Oncology Pharmacy Practice Specialty Examination Review Course that was sponsored by the SCSS. She also served on the ASHP Task Force on Science, the Pharmacy Practice Model Advisory Committee, was a participant in the Practice Model Summit, and served on the Steering Committee for the ASHP Leadership Conference. She was on the Expert Panel for the revision of the ASHP Guidelines on Preventing Medication Errors with Antineoplastic Agents, served as Chair of the Membership Development Advisory Group for ASHP, and has been a presenter and meeting programming associate for several clinical and scientific presentations at the Midyear Clinical Meeting. Dr. Goodin is a member of the ASHP Research Foundation Research Advisory Committee and has been a reviewer for a number of the foundation research grants and award programs.

Currently, Dr. Goodin serves on the Board of Pharmacy Specialties, where she is Chair-Elect, and previously served on the Oncology Specialty Council for five years. She is an active member of several other professional societies, including the American College of Clinical Pharmacy, the American Society of Clinical Oncologists, the Hematology Oncology Pharmacy Association, where she is the founding Chair of the Research Foundation, and the International Society of Oncology Pharmacy Practice.
