

## **ASHP Residency Accreditation Fee Schedule**

## **Key Points**

- The ASHP fee schedule is based on the calendar year (January December). Fees are invoiced annually in November for the subsequent calendar year and due within 30 days of receipt of invoice.
- Annual accreditation fees for new programs are assessed from the date of ASHP's receipt of the application for the initial calendar year
  - Example 1: Initial new program application received in April will be invoiced for threefourths of the applicable annual assessment rate
  - Example 2: Initial new program application received in June will be invoiced for one-half of the applicable annual assessment rate
- Each new program is assessed an initial application fee once the new program application has been approved and the program has been fully added to the database. This fee is due within 30 days of receipt of the invoice.
- Accreditation survey expenses are included in the annual assessment—there are no additional fees assessed during the year of a program's accreditation survey).
- The Annual Assessment Fee and Application Fee are subject to change yearly. Annual assessment fees and application fees are nonrefundable.

## **Summary of Changes**

With the harmonization of the Standard in 2023 that has resulted in streamlined survey processes and the incorporation of PGY1 Community-based residency programs into multiprogram accreditation visits where applicable, and with the revision of the Regulations in 2024 that has eliminated the designation of programs as "multisite" and limited all residency programs to a single primary practice site for all residents in the program with the exception of PGY1 Community-based Pharmacy residency programs sponsored by a College of Pharmacy, the fee schedule for the 2026 calendar year has been revised and streamlined to align with the above-mentioned changes.

The 2025 fee schedule documented below (originally published in July 2024) will continue to be used for the remainder of 2025 for all new pre-candidate and candidate programs.

The 2026 fee schedule incorporates all pharmacy residency program types including PGY1 Community-based Residency programs that are NOT sponsored by a College of Pharmacy. There is a separate fee schedule (Table 2) for Colleges of Pharmacy that sponsor a PGY1 Community-based Pharmacy residency program with **more than one primary practice site** that accounts for the additional primary practice sites. Additionally, the 2026 fee schedule includes the following changes:

- Elimination of assessment of fees for participating practice sites used >25% of the residency training program (fee schedule is now based only on primary practice sites)
- For organizations in which multiple residency programs for the same primary practice site/under the same ASHP Organization ID include a PGY1 Community-based Pharmacy residency program, the PGY1 Community-based Pharmacy residency program will be counted as one of the



programs in the bundled multiprogram rate on the fee schedule instead of with a different fee schedule

<u>Programs Applying for Pre-Candidate Status</u> are not subject to, nor included, in the below fee schedule tables. Rather, each program in pre-candidate status will be invoiced the initial application fee and an annual accreditation fee (annual accreditation fee is pro-rated as applicable based on application submission date for the initial year of pre-candidate status):

2025 application fee is \$1,550 and the annual fee is \$3,900 2026 application fee is \$1,600 and the annual fee is \$4,025

<sup>\*</sup> For PGY1 Community programs with a single primary practice site and where there are no other residency programs under the same ASHP Organization ID that were billed using the PGY1 Community Residency program fee schedule for the full 2025 calendar year, the increase in the rate will only be partially made in the 2026 calendar year and then will move to the above-mentioned single program rate in 2027 (i.e., for a PGY1 Community program billed at \$4,200 for 2025, if no other changes or addition of programs under the same ASHP Organization ID for 2026, the 2026 fee will be \$4,700 instead of the \$5,000 single program rate in Table 1).

<u>PGY1 Community-based Pharmacy Residency Programs</u> in candidate, accredited, and conditional status have not been subject to or included in the above fee schedule through the 2025 calendar year. PGY1 Community-based Pharmacy residency programs with a *single* primary practice site will be assessed in the above-mentioned 2026 fee schedule. The **pre-candidate status application fee** and the **pre-candidate annual fee** for PGY1 Community Pharmacy residency programs are assessed as outlined above for all programs.

<sup>\*</sup>Applicable for Existing PGY1 Community Programs Only: For organizations with PGY1 Community-based Pharmacy residency programs with a single primary practice site <u>and</u> where there are no other residency programs under the same ASHP Organization ID that were billed as such for the full 2025 calendar year, the increase in the rate will only be partially made in 2026 and then will move to the full single program rate in 2027 (i.e., for a PGY1 Community program billed at \$4,200 for 2025, if no other changes or addition of programs under the same ASHP Organization ID for 2026, the 2026 fee will be \$4,700 instead of the \$5,000 single program rate).

<sup>\*\*</sup>For Colleges of Pharmacy that serve as the program operator sponsoring a mix of both PGY1 Community-based residency program types with multiple primary practice sites as well as other residency program types, the applicable program fee in Table 1 will be assessed based on the number of programs plus \$500 per additional primary practice site used in the PGY1 Community-based residency program.



## **Multisite Programs**

For organizations that have one or more residency programs that have *not* notified Accreditation Services of a change from current multisite status to come into compliance with the 2024 Regulations as it relates to the use of multiple primary practice sites by October 31, 2025, the organizations will be billed for the 2026 calendar year using the multisite methodology used in previous years but with the 2026 rates (billing for the corresponding number of residency programs in the organization using the applicable fee table(s) plus one-half of the annual fee for one program for each additional primary practice site used). Organizations that have one or more multisite programs must be compliant with the 2024 Regulations by July 1, 2026.
